## How do we store your data?

Beyond the Big Five will keep your data as long as necessary.

## What are your data protection rights?

Beyond the Big Five would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Beyond the Big Five for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that Beyond the Big Five corrects any information you believe is inaccurate. You also have the right to request Beyond the Big Five to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Beyond the Big Five erases your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Beyond the Big Five restricts the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Beyond the Big Five's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Beyond the Big Five transfers the data that we have collected to another organization, or directly to you, under certain conditions.
